The rental fee is **\$55.00** per table. All tables are 2½' X 8'. Chairs will be provided. Reservations will be accepted on a first come, first serve basis, with a priority given to those dealers who participated in our 2025 Show. **To ensure reservations, you must pay all fees in advance.** We will do our best to honor locations from the previous year if your contract is received by **January 31, 2026.** Any contract received after this date will be placed where space is available.

Dealers will be allowed to bring their boxed sale items in at **12:00 pm** on Saturday, March 28th. **Boxes must remain closed, and nothing will be allowed on top of the tables until 1:00 pm.** The building will be locked at 5:00 pm Saturday evening.

Set-up time for the Show on Sunday, March 29th is from 7:00 to 8:30 am. **Those not set up by 8:30 am will forfeit their tables and all fees.** Show closing time is 3:00 pm. with building closing at 4:00 pm. **DEALERS MUST REMAIN SET UP FOR THE FULL TERM OF THE SHOW.** If you start packing and/or leave before the end of the show, you may not be offered a Contract for the coming year. We want to give all shoppers an opportunity to attend the full experience.

SUB-LEASING OF TABLES IS PROHIBITED. 40% of your wares must be bottles.

Only one assistant is allowed per dealer regardless of the number of tables contracted. Badges must be worn at all times.

The dealer agrees to be solely responsible for his/her contract, agents, employees, and assistants and releases the Baltimore Antique Bottle Club, Inc., its directors, officers, and members from all claims for theft or damage to person or property from any cause whatsoever during the occupancy of said dealer on the premises.

Contract Clauses

- **Smoking and the consumption of alcoholic beverages are prohibited inside the Hall.**
- In order to receive a refund, a cancellation request must be received at least TWO (2) weeks before the Show (**on or before Sunday March 15, 2026**). No-shows (i.e. absence without prior notification) may not be offered future contracts.
- Only bottles, stoneware, glassware, advertising, breweriana, and related/similar items along with tabletop **antiques – not collectibles** – are to be sold. We must insist that glass and related items remain the emphasis of the Show.
- Reproductions and repaired items must be clearly marked as such on the item. No artificially colored glass may be offered for sale at this show. Prices are to be clearly marked on all items.
- **No Weapons, Symbols of Hate or related materials are allowed for display or sale at our show.**
- There will be ***NO EARLY BUYERS*** at the Show.
- No hand trucks or small tables or boxes in the aisles. That creates Liability issues.
- Dealers must provide their own table coverings, and all tables are to be covered.
- We request that table cards identifying you as the dealer be visible throughout the Show.

SALES TAX: Maryland law requires that all dealers collect 6% Maryland Sales Tax. The Club is required to provide all dealers' names and addresses to the State Compliance (Sales Tax) Division. Dealers will be mailed a temporary 30 day license by the Compliance Division. Collecting and reporting Sales Tax is the responsibility of the dealer, not the responsibility of the Baltimore Antique Bottle Club, Inc.

<u>PLEASE NOTE:</u> Should the Baltimore Antique Bottle Club, Inc. be unable to hold the Show at the location and date mentioned due to inclement weather or other circumstances beyond its control, the dealer waives the right to any claim for damage or other compensation.

Disputes with security, management, show representatives and club members may result in the dealer and/or assistant being immediately removed from the show.

Any breach of this contract & clauses noted above may result in the dealer and/or assistant being immediately removed from the show and not being offered a contract for the coming year.
